# RE: HOMA BAY COUNTY FINANCE ACT FOR FY 2025/26

As a requirement in Sect. 132 and 133 of the PFM Act, 2012, the County Executive Member for Finance is expected to prepare a Finance Bill which becomes an Act upon approval by the County Assembly; a legal framework which outlines revenue raising measures for operationalizing and financing county budget estimates.

During FY 2025/26, the County Government of Homa Bay did not make any change to its pricing and tariffs systems. Consequently, the County shall collect ordinary Own Source Revenue (OSR) using the Homa Bay County Finance Act, 2023 as per the Kenya Gazette Supplement No. 9 (Homa Bay County Acts No.1) which was gazetted on 5<sup>th</sup> May 2023.

As a government, we remain committed to good governance, accountability and stewardship for public resources.

#### THE HOMA BAY COUNTY FINANCE ACT, 2023

AN ACT of the Homa Bay County Assembly to provide for taxation, imposition of fees and charges for services, and other revenue raising measures by the county government; to amend existing county revenue laws; and for matters incidental thereto

**ENACTED** by the Homa Bay County Assembly as follows—

#### PART I—PRELIMINARY

#### **Title and Commencement**

1. This Act may be cited as the Homa Bay County Finance Act, 2023 and shall come into operation, or be deemed to have come into operation once enacted into law by County Assembly within appropriate timelines.

#### **Interpretation**

2. In this Act unless the context otherwise requires—

Authority" means power given by the people of Homa Bay County through the County Assembly of Homa Bay;

"Authorized channel," means the method, mode or process of collection of county revenue or making payments to the county as approved by the County Government;

"Authorized Officer" means the County Executive Member for the time being in charge of Finance and Economic Planning or any person authorized by him/her in writing to act as such for the purpose of enforcing this Act;

"Business" means—

- (a) Trade, commerce or manufacture, profession, vocation or occupation;
- (b) Any other activity in the nature of trade, commerce or manufacture, profession, vocation or occupation;
- (c) Any other activity carried on or by a person continuously or regularly, whether or not for gain or profit and which involves, in part or in whole, the supply of goods or services

"Cess" means tax or fees charged for goods specified in the first schedule;

"County" means the Homa Bay County;

"County Government" means the County Government of Homa Bay;

"County Public Officer" means a County Public Officer within the meaning of Section 2 of the County Government Act, 2012;

"Receiver of Government Revenue" means the County Public Officer appointed pursuant to section 158 of the Public Finance Management Act, 2012 for collecting revenue for the County Government and remitting it to the County Receiver of Revenue;

"Collector of Government Revenue" means a person authorized or required by or pursuant to a revenue law or by agreement to collect revenue for the County Government and remit it to the County Receiver of Revenue:

"Enforcement Officer" means an officer designated as a county enforcement officer pursuant to Section 2 of the Homa Bay County Inspectorate Service Act, 2019;

"Executive Member" means the County Executive Committee Member for the time being responsible for Finance and Economic Planning;

"Township" means a town as defined under section 10 of the Urban Areas and Cities Act;

"Wholesaler" means a trader, who buys goods in bulk quantities and sell it in smaller ones:

"Travelling Wholesaler" means a person who, whether on his or her account or as the servant of another person, sells goods by wholesale other than in trading premises as defined in the Homa Bay County Trade (licensing) and Markets Act, 2015;

"Distributors" means the resellers of products, which cover a specific area or market:

# PART II— CHARGES, FEES, LICENSES, PERMITS, RENT AND CESS

#### **Market Fees and Charges**

- **3.** (1) The services listed under the First Schedule shall be charged a fee at the rate specified therein.
- (2) The impounding services listed under the Second Schedule shall be charged a fee at the rate specified therein.
- (3) The services listed under the Third Schedule shall be charged a fee at the rate specified therein.

#### **Extraction and transportation of building materials**

**4.** The transportation and extraction of the building materials listed under the First Schedule Part IV of this Act shall only be between 6:00 a.m. and 6:00 p.m. daily.

#### Cess

- **5.** (1) There shall be a levy to be known as Bricks/ hard core/ Ballast/ Marram/Sand harvesting, iron ore, farm produce/ jaggery/ poles, and timber cess among others from source to be levied at designated point of the County and to be pegged on the vehicle tonnage wage ferrying the products.
- (2) The Revenue department may from time to time identify points for revenue collection within the County.
- (3) A person who contravenes this section commits an offence and shall be liable to a fine not exceeding Kenya shillings fifty thousand or to imprisonment for a term not exceeding three months, or both.

#### **Licenses and Permits**

- **6.** (1) A person intending to operate a business listed in the Fourth Schedule shall apply for a specified license or permit.
- (2) A person applying for a business license or permit under this section shall pay the fees stipulated in the Fourth Schedule.
- (3) A person who applies for license under subsection (2) shall be issued with a license on the payment of the applicable fee, depending on the location and size of the business as specified in the Fourth Schedule.
  - (4) The following conditions are attached to Licenses and permits:
    - (i) Do not raise any payment over single business permit before your application is approved and proper bill is issued.
    - (ii) A separate application form must be completed in respect to each separate business establishment.
    - (iii) Single business permit paid and not collected within (30 days) from the payment date shall attract a such fee.
    - (iv) A permit can be cancelled/ refused to be issued if any of the County Acts or any written Law of the County is contravened.
    - (v) The permit is accountable document, malicious damage to it is an offense and if lost must be reported to the police.

- (vi) The single business permit must be conspicuously displayed at the business premise.
- (vii) Change of ownership of the permit or removal to another premise shall require a formal request/ application to the County Secretary.
- (viii) The permit is not transferrable and should only operate at the premises business type, plot number and location prescribed therein.
- (ix) The permit is subject to inspection at any time by the authorized officers.
- (x) Any offence under this Act shall be dealt with in accordance with any written Law/ Act of this County.
- (xi) The permit is not a receipt.
- (xii) Photocopy of the permit should not be displayed in the business premises.
- (5) A person who operates a business without a license or permit commits an offence and shall be liable to a fine of Kenya shillings:
  - (a) fifty thousand in the case of an individual; or
  - (b) one hundred thousand in the case of a registered business; or
  - (c) to imprisonment for a term not exceeding three (3) months.

#### Fees and Charges applicable to schedule Six to Eleventh

- 7. (1) A person operating a business or a trade stipulated under the Sixth, Seventh, Eighth, Ninth, Tenth Schedule or providing services requiring a permit stipulated under the Schedules shall apply for a permit and pay the stipulated fees and charges
- (2) A person who contravenes this section commits an offence and shall be liable to a fine of Kenya shillings:
  - (a) fifty thousand; or
  - (b) to imprisonment for a term not exceeding three months.

#### Licenses for Manufacture, Distribution or Sale of Alcoholic Drinks

**8**. (1) A person intending to operate a business listed in the Fourth Schedule shall apply for a liquor license pursuant to the provisions of the Homa Bay County Alcoholic Drinks Control Act, 2015 and pay the stipulated fees and charges.

(2) A person who contravenes this section commits an offence and shall be liable to pay penalties provided for in Section 31(2&3) of the Homa Bay County Alcoholic Control Act, 2015.

#### PART III - PAYMENT

#### **Payments to the County Government**

- **9.** (1) All payments to the County Governments made under this Act shall be paid through the authorized channel in accordance with Section109 of the Public Finance Management Act Cap. 412C (Revised 2012).
- (2) The Revenue Collector authorized by the County Government to collect revenue shall have a uniform and/or an identification card issued by the County Government which shall be worn visibly by such County Revenue Collector.
- (3) All the Departments of the County Government shall serve and be responsible for the collection and remittance of the revenues to the County Revenue Account. *e.g.* Health, Lands, Tourism and Trade etc.
- (4) The County Government of Homa Bay adopted cash less payment through the following modes;
  - 1. Paybill No. 0434343
  - 2. USSD Code \*603#
- 3. Bank deposits at KCB County Revenue Collection Account No.1140763555
- (5) Every person who is authorized to collect revenue for the County Government shall account for every revenue collected on daily basis.
- (6) Every person who makes a payment through an authorized channel shall demand an official receipt for each such payment and every payment made.
- (7) Every person who is authorized by the County Government to collect revenue shall remit in whole the same amount within the time specified and to the institution duly authorized to receive such remittance.
- (8) A person shall not receive or collect any money on behalf of the County Government unless such a person has been duly appointed to do so or has authority as the receiver and collector of County Government Revenue from the Executive Member.
- (9) A person who contravenes the provisions of this section commits an offence and shall be liable to a fine not exceeding three times

the Amount not remitted or to imprisonment for a term not less than one year or both.

#### Appointment of agents and their duties

#### **10.** (1) In this section —

"agent" means a person appointed as such under subsection (2);

Under this subsection "appointment notice" means a notice issued by the County Executive Committee Member appointing an agent;

- (2) The County Executive Committee Member may by written notice addressed to any person—
  - (a) Appoint any person to be an agent of the County Government for the purposes of the collection or recovery of charges, permit fees, license fees, rent, cess and such other fees, as may be necessary for carrying out the purposes of this Act; and
  - (b) Specify the amount of charges, permit fees, license fees, rent, cess and such other fees to be collected or recovered by the agent.
- (3) An agent appointed under this section shall enforce and ensure due compliance with the provisions of this Act and shall remit all revenue collected to the County Government through the County Receiver of Revenue or as may be otherwise instructed in the appointment notice.
- (4) Where an agent claims to be, or to have become unable to comply with subsection (3), such shall, within seven days, notify the County Executive Committee Member in writing, setting out fully the reasons for his inability to comply, and the County Executive Committee Member shall accept the notification and cancel or amend the appointment notice accordingly.
- (5) Unless and until a notification is given by an agent under subsection (4), all moneys for the payment of charges, permit fees, license fees, rent, cess and such other fees specified in the agent's appointment notice shall be presumed to be held by him and this money shall be due and payable to the County Government.
- (6) For the purposes of this section, the County Executive Committee Member may, by notice in writing, at any time, require any person to furnish him or her, within reasonable time not being less than seven days from date of service of the notice, with information showing any monies which may be held with the agent for, or due by the agent to the government.

- (7) Where an agent fails to pay an amount of money collected under this section within the time specified within the notice, the provisions relating to this Act regarding the collection and recovery of revenue shall apply.
- (8) Any person who impersonates a collector of county revenue shall be liable upon conviction to pay a fine not exceeding Kenya Shillings five hundred thousand or to imprisonment for a period not exceeding three years or both.
- (9) An agent who makes a payment to the County Government under this section shall for all purposes be deemed to have acted under the Authority of the County Government and shall be indemnified in respect of that payment against all proceedings and all processes notwithstanding the provisions to the contrary in any written law, contract and agreement.
- (10) Section 7(5) of the Homa Bay County Alcoholic Drinks Control Act, 2015 shall be amended to read 'Receipts, earnings or accruals of the Fund and its balances at the close of each financial year shall be paid into the County Revenue Fund.'

# PART IV—ENFORCEMENT POWERS AND PRIVILEGES Establishment of the County Enforcement Unit

- 11. (1) Part II and III of the Homa Bay County Inspectorate Service Act, 2019 shall apply with respect to the establishment of County Laws Enforcement and Inspectorate Unit; recruitment, deployment, ranking and discipline of the enforcement officers.
- (2) Part IV of the Homa Bay County Inspectorate Service Act, 2019 shall apply with respect to powers of the Enforcement Officers.

#### **Power and Privileges of Enforcement Officers**

**12.** The Homa Bay County Inspectorate Service Act, 2019 shall operationalize the Finance Act, 2023 with respect to powers and privileges of enforcement officers.

#### Disposal of seized goods

- 13. (1) Where any vehicle, instrument, goods, articles or money has been seized under this Act, the same may be retained for a period not exceeding three months or if, within that period; proceedings are commenced for any offence under this Act, until the final determination of those proceedings.
- (2) Where any goods are seized and detained under this Act, they shall be returned, less any portion which has been reasonably utilized for the purpose of any tests, to the person from whom they were seized within a period of three months after the date of seizure unless within such period

some person is charged with an offence under this Act and such offence was committed in relation to or in connection with such goods.

- (3) Where any perishable goods have been seized under any provision of this Act, the officer who has seized the goods shall within 48 hours report to a magistrate the fact of the seizure and if the Magistrate is satisfied that the goods are perishable, he may authorize the officer to dispose off the goods as the Magistrate may think fit.
- (4) Where any proceedings are taken for any offence under this Act, the Court by or before which the alleged offender is tried may make such order as to the forfeiture of the goods in respect of which such offence was committed or as to the disposal of any goods or money seized in connection therewith as the court shall see fit.
- (5) Where animals are the subject of seizure, the retention period shall be three days provided with water and basic feeds at the expense of the owner. After elapse of three days without the owners initiating recovery the impounding officer shall under this Act be authorized to dispose them off at the nearest auction at a cost commensurate to the status of the animals.
- **14.** A seizure certificate shall be issued to the person from whom the articles are seized and shall be in a prescribed form. A register of seized goods shall be maintained.
- **15.** (a). Any person or licensee who gives false information or makes false statement either orally or in writing in connection with a call of information made under this Act or in connection with an investigation into the commission of an offence under this Act, or abets the commission of the offence shall be guilty of an offence.
- (b). Any person found guilty under section 15(a) above shall be liable to fine not exceeding fifty thousand or a jail term of three years or both.
- **16.** Any person who operates unregistered business shall be guilty of an offence.
- 17. Any person who obstructs or hinders or assaults a designated officer in the performance of any duty or act imposed or authorized by this Act or who fails to comply with any reasonable request made by a designated officer in the course of his duty under this Act, shall be guilty of an offence.
- **18.** Anybody who parks any article, picks passengers, exposes goods for sale, disposes refuse and performs any function at non-designated place shall be guilty of an offence

#### PART V— OFFENCES AND PENALTIES

#### **General Offences**

19. Any person who commits an offence under this Act, for which no penalty is provided, shall be liable, on conviction, to a fine not exceeding one hundred thousand shillings or to imprisonment for a term not exceeding one year or both.

#### Offences involving staff of the County

- **20.** A member of staff of the County government or any other person having a duty to perform under this Act who
  - (a) makes, in any record, or document required to be kept or made by that person, an entry which he or she knows or has reasonable cause to believe not to be true or to be false;
  - (b) Willfully refuses to do anything which he or she knows or has reasonable cause to know is required to be done;
  - (c) interferes with any other person or process under this Act, so as to defeat the provisions, requirements or purposes of this Act;
  - (d) Where required under this Act to do anything to give effect to the provisions of this Act, fails to do such thing;
  - (e) Without reasonable cause omits to do something in breach of his or her duty under this Act;
  - (f) Willfully contravenes the provisions of this Act to give undue advantage or favor to another person;
  - (g) Fails to prevent or report to the County Government or any other relevant authority, the commission of an offence committed under this Act; commits an offence and is liable on conviction, to a fine not exceeding two hundred thousand shillings or to imprisonment for a term not exceeding one year, or both.
- 21. To effect and ensure compliance with this Act and more specifically on the payment of the levies, fees, and charges as per the schedules provided herein it is enacted as hereunder.
  - (1) For administrative, supervision and inspectorate purposes;
  - (a) The County shall carryout registration of all Businesses and Properties within Homa bay County. Failure to register will attract a penalty as per the approved fees and charges.
  - (b) Single Business Permit issued expires on 31st December of every calender year. Failure to apply and obtain a Single Business Permit by the 31st March of each year, the fees

- chargeable shall attract a penalty as indicated in the fourth schedule part X of the Homa Bay County Finance Act,2023.
- (c) That failure by a factory to remit cess by the 15th day of commencement of a new quarter, the unpaid cess shall attract a penalty of 10% on the total cess withheld quarterly.
- (d) That the harvesting of sand, hard-core, murram and other royalties shall only be permitted after taking into consideration all relevant approvals on environmental and public safety concerns from relevant bodies.
- (e) That it shall be an offence to excavate, dig and or mine any of the products named in (d) above without due regard to environmental and public safety concerns.

Any person who commits an offence under this Act for which no penalty is provided shall be liable, to a fine not exceeding Fifty Thousand Shillings or imprisonment for a term not exceeding one year or both

#### PART VI— MISCELLANEOUS PROVISIONS

#### **Government Tax waivers and variations**

**22.** The Executive Committee member may exempt waiver or vary fees or charges payable under this Act in accordance to the criteria prescribed in the regulations.

#### **Amendment of Schedules**

- 23. (1) The Executive Member may by order published in the gazette can amend any of the schedules subject to any written national or county law.
- (2) Any order made under subsection (1) shall be laid before the County Assembly without unreasonable delay for consideration and approval.

#### **Savings**

- 24. (1) Any charges, permit fees, license fees, rent, cess and such other fees payable to the County Government at the commencement of this Act which are not included in any of the Schedules to this Act, shall continue to be chargeable by, and payable to the County Government unless they are repealed by an Act of the County Government or until an Act of the County Government on such charges, permit fees, license fees, rent, cess and such other fees is enacted.
- (2) All directions, resolutions, orders and authorizations on, or relating to financial management, including the collection and administration of fees and charges given or issued by the previous county

councils, municipal councils, town councils or urban councils, before the commencement of this Act shall be deemed to have been given, issued or made by or under the authority of the County Assembly until the expiry or repeal of those directions, resolutions, orders and authorizations, and shall continue, with the necessary modifications, to apply, be paid and administered under this Act: provided that this sub-section shall also apply to such fees and charges levied by various ministries and departments of the national government in respect of functions devolved to the county governments under part 2 of the Fourth Schedule of the Constitution of Kenya which fees and charges shall be levied by the County Government on transfer of the devolved functions.

#### Cessation

**25.** Unless otherwise provided in this Act, the rates for Cessation fees, charges, licenses, cess or rent, applicable before the commencement of this Act in respect of any business, activity, goods or services listed in the schedules, shall cease to apply.

#### Variations by other laws

26. Notwithstanding the provisions of this Act, the fees and charges may be varied upon the enactment of any county law regulating any of the stipulated licenses in the schedules or any appropriate approval shall apply.

#### **Transition**

27. Any person who, before the commencement of this Act was a holder of a valid license or permit provided under this Act shall continue holding such license or permit until the stipulated expiry date.

#### **Regulations**

**28.** The County Executive Committee Member may make regulations for the better carrying out of the purposes and provisions of this Act.
