The meeting was called to order by the chairperson and prayer given by Mary Opiyo. The chairman then welcomed member to meeting by way of self-introduction. Each member had chance to introduce his or her self as this was the first meeting to be held between the board members and the manager.

Communique from the chairman

The chairman welcomed members in to the meeting by way of thanking them to have found time within their busy scheduled to attend the meeting. He reiterated and recognized the short notice of the summoning of the meeting. He explained that the circumstances why the meeting had to in that short duration.

- To welcome the manager and hand over the instruments for work
- Comply with County busy scheduled otherwise the next meeting could have been in September but that will have hindered a lot of work

• That the meeting was special one and had only one agenda of handing over by the acting manager Mr. Jacking (Sub County Administrator who has been acting since May and taking over by Mr. Salmon Ogutu Owii as the substantive Manger from 8th August 2023. So the minutes of the previous board meeting were not read.

The chairman noted with appreciation and recognition the harmonious mutual and seamless working relationship between the Ndhiwa Constituency National Government Constituency Development Fund (NG_CDF) through area MP Hon Martin Owino and Ndhiwa Municipality through the municipal Board. This was echoed as best practice that should be scaled up in other jurisdictions. To this regard, the Municipality manager and the staff have been hosted by the NGCDF through the NGCDF chairman Mr. Joseph Ondenge at the Assistant Police commissioner building.

- It's agreed that NGCDF will permit municipality to use 5 offices.
- That in the next 2 months NGCDF will move to KMTC building
- That the Municipality will continue to use the NGCDF board room for their board meetings
- The fund manager office will be the municipal manager office and currently the fund manager uses the office twice a week (Tuesday and Thursday) the rest of the days, the office will be wholly used by the municipal manager

During the meeting it anoted that that KUSP will help in the development of the plan for example (5 years Urban integrated development plan (IDEP), strategic Plan (SP), Annual development Plan (ADP).

The ESP will support the development and construction of the Ndhiwa Municipality Market which already been advertised by the national government on 9th August 2023.

Through the board Hon MP Martin Owino and the Chairman, the is the proposed Kanyamwa-Kayambo-Kwamo 136 project to stand on the 5 acres land at cost of about 80M

It was noted that for the financial year 2023/2024 the County government has allocated 10m for development covering the following project

- 1. Lighting
- 2. Drainage
- 3. Dumping site

The meeting was also dully informed that the Kenya Urban Roads Authority are coming to Homa Bay and will be hosted in Ndhiwa. The municipality has to find office spaces for them. KURA will bitumen the roads within the Municipality Jurisdiction

It is anticipated that Municipality will receive fund from national government similar to CDF called Municipality Development Fund. The boundary for the municipality is under review and all the wards will benefit. The boundary will be along the Gor Mahia ring road and is proposed to be from Ratanga to Ongeng.

As chairman briefed the members, the following were agreed on;

- 1. Endless potential motto of the county be clarion call for all the municipality functions and operations
- 2. That Ndhiwa is agricultural Municipality and any other planning should link it with Ruma Park national as the municipality is anticipated to agricultural city with national park inside

- 3. Manager to schedule all the committee meeting in consultation with chief officer before end of September and have full board meeting
- 4. All the board members to attend the devolution conference in Eldoret starting from 14th-19th August 2023. Members to use their own money and will be reimbursed if by that time County had not wired the money in to the account and the account had not been opened
- 5. The agreed to have ICT personnel hired to support in the development of the website for the municipality
- 6. The board continue and every board member to try to mobilize resources for the growth of the municipality
- 7. Due diligence be followed before any project is undertaken.
- 8. Public participation remains Conner stone of all the projects and as enshrined in the constitution
- 9. The chairman to share the MOU from DHA and members to give feedback within August. Share the feedback with manager before end of August
- 10. Members to walk to the designated market place for familiarization of the anticipated market construction on the very day of the meeting
- 11. The motto of the municipality is GREEN JEWEL
- 12. Once the NGCDF has left the office for the municipality, due diligence be followed for the renovation of the office in consultation with Chief Officer before end of December 2023
- 13. The manager to begin to have engagement with busy/market community representative. His contact be given by Commissioner Ondenge before end of August 2023
- 14. The following document be availed for the members to read: municipality chatter and launching be planned to be presided by the Governor
- 15. Audit committee to be trained as the money will be available and supported by the County
- 16. Board members to be inducted by the County
- 17. Performance contract be finalized and signed between chairman and the manager
- 18. Manager to tease out activities to be accomplished with 100 days
- 19. Finalized work plan
- 20. Manager to follow up the initial payment for board members who went to Naivasha
