

Min01/30/06/2023: PRELIMINARY

The meeting started with a word of Prayer from the Clergy. The Sub County admin then welcomed all for the meeting. He later gave out an opening speech highlighting the activity of the day. The administrator later welcomed Prof. Ogweno who gave a brief speech on environmental issues and later welcomed other facilitators to make their comments.

Prof. Ogweno then welcomed Mr. Abila who is the Municipal Chair to make his comments and later introduced Board Members for the meeting. The members are;

- The Municipal Chair then welcomed Mr. Charles Obondo Chief Officer Housing and Urban Development to make his comments and observation.

Mr. .Obondo clarified the following items;

- That all activities of municipality must be discussed by the people.
- All guidelines and policies regarding municipality should involve the public.
- MIDEP (Municipality Integrated Development Plan) i.e. what should be
 done in the municipality in the next five years. He clarified that Donors and
 Investors can only provide for what is within the MIDEP hence members
 were asked to contribute fully.



- Urban area Solid waste-Providing a comprehensive solid waste management
- · Gender Inclusion and participation framework
- · County /Urban Intergrated Strategy Paper
- Land Use plan

After making his comments he welcomed Dr.Peter Ogola -CEC who had the following comments to make;-

Oyugis has been identified as one of the potential beneficiaries by World Bank and awarded Ksh.400m for Municipal Development.

He advised the members of the public to avoid politicking and give development a chance by supporting the Board members who are in place.

The issue of gender thresh hold which was an area of concern had been solved by selecting one more female to meet the one third gender rule.

He also acknowledge that there were problems within Oyugis which includes Slaughter area land grabbing among others. He cautioned all land grabbers or those encroaching Government land to deceits from doing so as the original records are available.

He affirmed that all inputs made by the public would be considered and that interest of individual group should be interest of the community.

Facilitator 3 talked at length on Waste management especially on handling of solid wastes (Solid waste collection).

The following methods were identified to be ideal for waste management;

- Issues of liquor licenses should be revived especially operators around Kendu Bay Junction and Kosele areas.
